# NaTran & Storengy launch Trensitis, a new subsidiary dedicated to green maintenance of gas infrastructures



**Trensitis, a new subsidiary specializing in green maintenance of gas infrastructure, is 70% owned by NaTran, France's leading gas transmission operator, and 30% by Storengy, Europe's leading underground gas storage operator. Trensitis's activities help reduce methane emissions during industrial maintenance operations. Trensitis is committed to environmental responsibility, in line with the commitments of its shareholders.**

### Technical expertise serving energy transition

The new European regulatory framework strengthens requirements for reducing methane (CH<sub>4</sub>) emissions by strictly limiting releases.

In this context, European operators must rely on innovative solutions, including mobile recompression systems able to efficiently handling different volumes of gas during planned maintenance and construction operations.

This is the very purpose of Trensitis. The joint venture is developing unique expertise in the use of mobile gas boosters — compressors capable of transferring pressurized gas between different sections of a facility, thereby preventing methane emissions.



Trensitis has a fleet of 15 mobile gas boosters units of various ranges, tailored to the diverse needs of its customers.

Based in Conflans-Sainte-Honorine (France) and backed by an initial investment of €25 million, Trensitis aims to be a key player in green gas maintenance in France and in Europe, thanks to a model that combines innovation, agility and environmental commitment. The Trensitis teams are made up of specialized engineers and technicians. The joint venture is currently in the process of increasing its workforce of Field Service Engineers with the objective of reaching around ten staff members by the end of 2026.

**Eric Courtalon**, CEO of Trensitis, explains: "The creation of Trensitis is fully aligned with the energy transition ambitions driven by our shareholders, NaTran and Storengy. By placing energy efficiency and carbon footprint reduction at the heart of our solutions, we are helping to build a more sustainable and responsible gas industry. Industrial

performance is being built right now with flexible and environmentally friendly solutions."
